THIS TRUST DEED is made the eighth day of March One thousand nine hundred and forty-four by SIDNEY FIELD and MONA ISABEL FIELD his wife both of Longthorns Blandford in the County of Dorset (hereinafter called 'the settlers').

WHEREAS:

- (1) This Declaration is supplemental to a Conveyance dated the Twenty-ninth day of September One thousand nine hundred and forty-three and made between the Bradford Property Trust Limited of the one part and the Settlers of the other part.
- (2) The Settlers intend that they shall hold the property comprised in the said Conveyance being land situate at Milborne St Andrew in the County of Dorset (hereinafter called 'the Trust Premises') upon certain charitable trusts as hereinafter mentioned.

NOW THIS DEED WITNESSETH that the Settlers hereby declare that they hold the said property upon the trusts and subject to the powers and provisions set out in the first schedule hereto

IN WITNESS whereof the parties hereto have hereunto set their hands and seals the day and year first before written.

THE FIRST SCHEDULE BEFORE REFERRED TO.

- 1. THE Settlors shall forthwith apply to the Charity Commissioners for England and Wales for an Order vesting the Trust Premises in the Official Trustee of Charity Lands and upon such order being made the Settlors shall cease to be the Trustees of the Trust Premises and the Charity shall thereafter be administered and managed by the members for the time being of the Committee of Management herein after mentioned as the Trustees thereof.
- 2. THE Trust Premises shall be held upon trust for the purposes of physical and mental training and recreation and social moral and intellectual development through the medium of playing fields reading and recreation rooms library, lectures, classes, recreations and entertainments or otherwise as may be found expedient for the benefit of persons resident in the neighbourhood of the Village of Milborne St Andrew or the Parish of Milborne St Andrew (hereinafter called 'the said area') without distinction of sex or of political religious or other opinions subject to the provisions of these presents.
- 3. THE general management and control of the Trust Premises and the arrangements for their use shall be vested in a Committee of Management (hereinafter called 'the Committee') consisting of not more than Fifteen members of whom four shall be elected at the first General Meeting referred to in Clause 4 hereof in the first instance and on each subsequent appointment of members at the Annual General Meeting. The organisations mentioned in the second column of the second Schedule hereto shall each have the right to appoint one member of the Committee both in the first instance and on the occasion of each annual appointment of members. The persons whose names appear in the first column of the second Schedule hereto have been appointed by the organisations mentioned opposite their respective names in the second column of that Schedule and shall together with the members appointed at the first General Meeting as aforesaid be the first members of the Committee. Until the first General Meeting has been held the persons named in the first column of the second Schedule shall have power to act. In addition to the members of the Committee appointed above, the Committee shall have power to co-opt not more than two members to represent interests in the said area not represented by any organisations.
- 4. THE first General Meeting to be convened by the Committee shall be held in October 1944 and thereafter there shall be an Annual General Meeting to be convened by the Committee in the month of April in each year by one week's notice to be affixed to some conspicuous part of the Trust Premises or other conspicuous place or places in the said area of the inhabitants of the age of eighteen years or upwards of either sex of the said area for the purpose of receiving the Report and Accounts of the Committee and for accepting the resignations of members of the Committee and for the purpose of appointing four members under Clause 3 hereof and for taking such action as it may decide under Clause 8 hereof.

- 5. ALL members of the Committee shall retire annually at the Annual General Meeting. Every organisation entitled to appoint a member of the Committee to take the place of a member retiring at an Annual General Meeting shall make the appointment at any time within one month before the Annual General Meeting at which the retiring member of the Committee shall retire.
- 6. A casual vacancy arising from the death or resignation or removal of a member of the Committee shall be filled by the organisation by which such member shall have been appointed and the person appointed shall retire at the time when the vacating member would have retired. In the event of a vacancy arising through the death or resignation or removal of a member of the Committee appointed by the Annual General Meeting the Committee shall have power to fill such vacancy until the next Annual General meeting.
- 7. IN the event of any other organisation being formed in the said area with aims of a social, recreational or educational character not inconsistent with those upon which the Trust Premises are held hereunder the Committee shall have power to allow such new organisations to use the Trust Premises or any part thereof and shall also have power by a Resolution of the Committee passed at a meeting at which not less than two-thirds of all the members of the Committee vote in favour of the Resolution to allow such new organisation to appoint an additional member of the Committee in the same manner as if such new organisation had been mentioned in the second column of the second Schedule hereto and for this purpose the total number of members of the Committee as provided for in Clause 3 hereof may be increased but no such resolution shall be effective until it has been approved by an Order of the Charity Commissioners.
- 8. IF any organisation entitled to appoint a member of the Committee ceases to exist or fails to make an appointment in manner aforesaid before the Annual General Meeting in any year the Annual General Meeting shall decide in what way if at all the vacancy shall be filled.
- 9. THE proceedings of the Committee shall not be invalidated by any vacancy among its members or by any defect in the appointment or qualification of any member.
- 10. THE Committee may from time to time make and alter Rules and Regulations for the conduct of its business and for the summoning and conduct of its meetings and in particular with reference to:-
 - (a) The terms and conditions upon which the Trust Premises may be used for entertainments, meetings, social gatherings and other purposes and the sum (if any) to be paid for such use.
 - (b) The appointment of an Auditor, Treasurer and such other unpaid officers as it may consider necessary and the fixing of their respective terms of office,
 - (c) The engagement and dismissal of such paid officers and servants for the Trust Premises as it may consider necessary.
 - (d) The number of members who shall form a quorum at its meetings provided that the number of members who shall form a quorum shall never be less than a third of the total number of members of the Committee.
- 11. ALL payments in respect of the use of the Trust Premises and donations for the benefit thereof shall be paid into a Trust Account at Lloyds Bank Limited at Blandford or at such other Bank as shall from time to time be substituted therefor by the Committee.
- 12. THE moneys standing to the credit of the said Account shall be applied as the Committee shall decide in erecting repairing and insuring buildings on the Trust premises or the furniture and effects therein and in paying all rent (if any) rates taxes salaries of paid officers and servants and other outgoings and in providing

furniture games books newspapers periodicals and other literature and means of recreation and otherwise for the upkeep and improvement of the Trust Premises and buildings now or hereafter to be erected thereon.

- 13. THE Committee may upon the vote of a majority of its members and (when necessary) with the consent of the Charity Commissioners from time to time by mortgage or otherwise obtain such advances on the security of the Trust Premises or 'any part thereof as may be required for maintaining extending or improving the same or any part thereof or erecting any building thereon or for the work carried on therein and may continue or repay in whole or in part and from time to time any existing Mortgage or Charge on the said premises.
- 14. IF The Committee by a majority decides at any time that on the ground of expense or otherwise it is necessary or advisable to discontinue the use of the Trust Premises in whole or in part for the purposes hereinbefore indicated it shall call a meeting of the inhabitants of the age of eighteen years or upwards of the said area of which meeting not less than Fourteen days' notice (stating that a resolution will be proposed thereat) shall be posted in a conspicuous place or places on the Trust Premises and advertised in a newspaper circulating in the said area and if such decision shall be confirmed by a majority of such inhabitants present at such meeting and voting the Committee may with the consent of the Charity Commissioners let or sell the Trust Premises or any part thereof. All moneys arising from such letting or sale (after satisfaction of any liabilities properly payable thereout) shall with such consent as aforesaid be applied either in the purchase of other premises approved by the Committee and to be held upon the trusts for the purposes and subject to the provisions hereinbefore set forth (including this power) or as near thereto as circumstances will permit or towards such other charitable purposes or objects for the benefit of the inhabitants of the said area as may be approved by the Charity Commissioners and meanwhile such money shall be invested in the name of Official Trustees of Charitable Funds and any income arising therefrom shall either be accumulated (for such time as may be allowed by law) by investing the same and the resulting income thereof in like manner at an addition to and to be applied as the capital of such investments or shall be used for any purpose for which the income of the Trust Premises may be properly applied.
- 15. IF any Rules or Regulations made under the power in that behalf hereinbefore contained are inconsistent with the provisions of these presents the latter shall prevail.
